

Introduction- Should Trees Have StandingLegal standing is a term which applies to the ability of a person, or parties to demonstrate their position before a court. In the context of environmental law, there has been great discourse regarding the nature of legal standing and its applicability to natural objects. This includes forests, oceans, rivers, and other objects which ought to have some degree of recognized rights but do not have the faculties to independently obtain them. Christopher D. Stone has become a forerunner in the environmental movement by writing his seminal book, "Should
